Application for Accreditation Standards Applications

In Spring 2013, the Planning and Priorities Committee began facilitating the process for our next Accreditation Self-Evaluation. In adherence to Policy 2120: Process for Institutional Accreditation, the committee has completed the following steps:

January 14, 2013
Planning & Priorities convenes and begins drafting the application form to serve on an Accreditation Standards Committee.

February 1, 2013

Applications to serve on a Standards Committee are sent via email to Academic Monthly, Adjunct Faculty & Classified mailing lists with a March 1 deadline.

February 6, 2013

The application is posted to The Pulse.

February 28, 2013

Students are sent the application via email. The deadline to apply is extended to March 22.

March 25 to April 8, 2013

P&P reviews applications and finalizes the Standards Committees.

April 22, 2013

All applicants are contacted regarding their inclusion on a Standards Committee.

September 11, 2013

Applications to Serve on a Writing Team are sent via email to Associated Students, Academic Monthly, Adjunct Faculty & Classified mailing lists with an October 15 application deadline.
